I. General

Hickory Grove Apartments, Arnot Associates I, L.L.C, Arnot Associates III, LLC, Arnot Realty Corporation and its affiliates (hereinafter referred to collectively as "we" or "Arnot") respect the privacy of every individual who visits this website or responds to our interactive advertisements. This Privacy Statement outlines the information we will collect and how we will use that information.

Please note, that this website and the privacy practices described in this Privacy Statement are directed to and apply only to residents of the United States.

II. Personally Identifiable Information

When you visit this website or interactive advertisements, we will not collect any personally identifiable information about you (such as your name, address, telephone number, social security number, billing and shipping information, credit card information or e-mail address), unless you provide it to us voluntarily.

IV. Security

We are committed to keeping secure the data you provide us, and will take reasonable precautions to protect your personally identifiable information from loss, misuse or alteration. Agents or contractors of Arnot, who have access to your personally identifiable information to permit them to provide services for us, are required to keep the information confidential and are not permitted to use this information for any other purpose than to perform those services for us.

V. Children

Arnot has no intention of collecting any personally identifiable information from individuals under thirteen years of age. Where appropriate, we will specifically instruct children not to submit such information on our websites or advertisements. VI. Non-Personally Identifiable Information Collected Automatically
